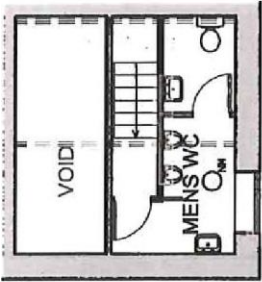

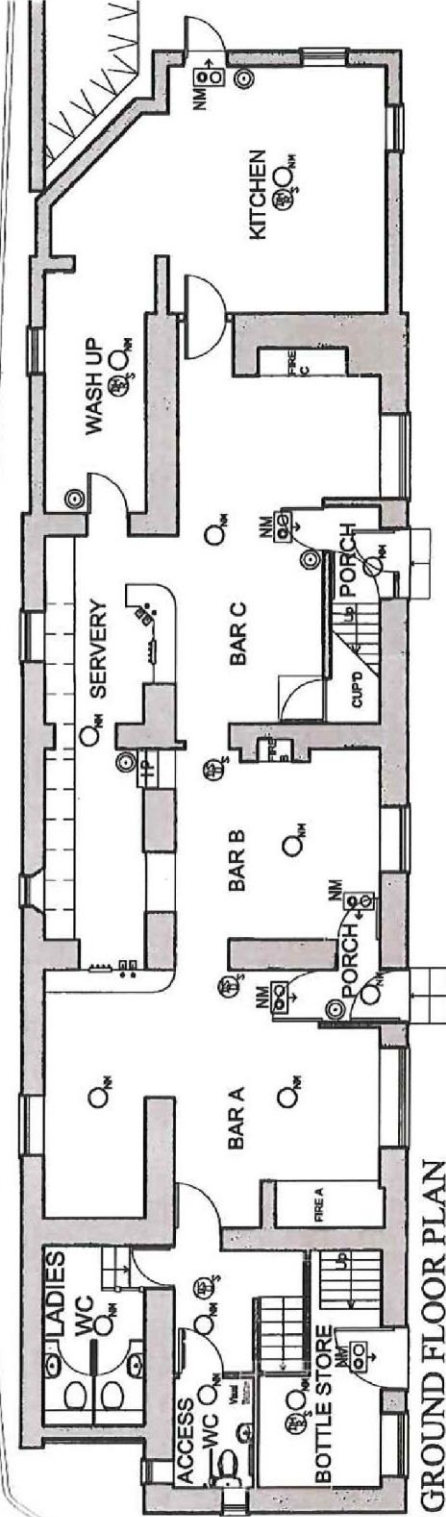

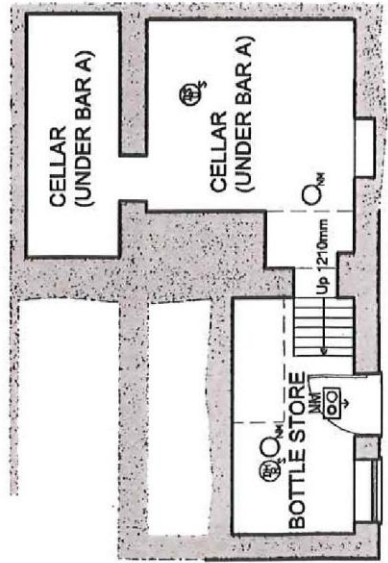
MEZZANINE FLOOR PLAN
