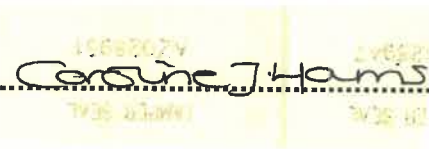

Annex 1

Mandatory conditions

MANDATORY CONDITIONS FOR THE SUPPLY OF ALCOHOL

(1) No supply of alcohol shall be made under the premises licence—

(a) at a time when there is no designated premises supervisor in respect of the premises licence, or

(b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

(2) Every supply of alcohol under the premises licence shall only be made or authorised by a person who holds a personal licence.

EMBEDDED BENEFITS

REGULATED ENTERTAINMENT

Recorded music and recorded singing may be provided at any time.

Unless otherwise specified on this licence, no regulated entertainment shall take place at the premises with the exception of pre-booked private events limited to the provision of music and dancing for pre-invited guests.

LATE NIGHT REFRESHMENT

Late night refreshment may be provided for a period of not more than 30 minutes after the hours permitted for the sale of alcohol or until the hour that the premises closes, whichever is the earlier.

Annex 2

Conditions consistent with the Operating Schedule

a) General – all four licensing objectives

On-going training of staff and awareness of legal and social obligations shall remain a priority.

b) The prevention of crime and disorder

Continual revision of security measures shall be taken by the owners. In-house training of staff shall be undertaken, including documented requirements/disclaimers in the event of owner's holiday. Pubwatch scheme and relevant notices displayed. Neighbourhood watch and relevant notices displayed

c) Public safety

Control of capacity at any function shall be maintained.

d) The prevention of public nuisance

Notices requesting respect to neighbours shall be displayed. Staff awareness of noise levels on premises shall be maintained. All music and skittles to cease by 00:00, except New Year's Eve or special events. Management shall continue careful supervision and control of noise.
